#### 1. Background

#### 1.1.Please refer briefly to any major fields of cooperation characterising the existing bilateral relations between the BS and the DS.

Bilateral relations under the FM 09-14 were strengthened at national, programme and projects' level and results was seen in all 4 dimensions: extent of cooperation, shared results, improved knowledge, mutual understanding and wider effects. DS partners were involved in almost 37% of all projects which resulted in valuable cooperation for both sides in climate change, research and green innovations, culture, development of capacity at state, municipal and regional level, strengthening civil society and supporting the reform of correctional services. NGO fund established good cooperation with Norwegian Helsinki Committee. As well as within the Bilateral fund at national level several European level events were supported, e.g., "Riga – the European Capital of Culture in 2014" and "Latvian presidency of the Council of the EU 2015" what contributed in valuable cooperation with DS experts in broader sense and ensured public awareness about the FM and the DS at the high/EU level.

Under FMs 14-21 continuation of already established strong cooperation between DPPs and POs will be ensured in areas of local development, research and education, business development, environment and climate change and capacity building of correctional services, which facilitates development of bilaterally relevant programmes. In addition, further support will be provided from the BF to an already established cooperation within the area of independent media development (see section 5 "Major Activities").

#### 1.2. Were there any lessons learned from the work to strengthen bilateral relations under the Financial Mechanisms 09-14? Briefly refer to past experiences, highlighting successes that can be built on.

Under the FM 09-14 DPPs, for example, in Climate programme and Capacity building programme, provided significant contributions to promote partnership between Latvian and DS institutions. For some programmes, for example Research and Scholarships Programme, main challenge for POs was a lack of interest from project promoters' side in the Bilateral fund at programme level measures as projects were already bilateral and DS partners were involved in core project activities. Another challenge was lack of DS partners' capacity as all 15 Beneficiary states were looking for partners simultaneously to involve them in bilateral activities. Since under FMs 09-14 bilateral cooperation was implemented at different levels then further under FMs 14-21 is possible to continue established cooperation and extend it.

## 1.3. Are there any on-going initiatives or upcoming events of importance for bilateral relations to build on? Could initiatives be tied to major events in the Donor or Beneficiary States (state visits, international chairmanships, EU Presidencies, European Capital of Culture, etc.?)

Several events of bilateral importance are coming up during the lifetime of this work plan and could potentially be supported under the BF, including:

- 1) Latvian Centenary Celebrations events in all Latvia and abroad (2017 2022);
- 2) Latvia and Norway will celebrate 100 years since Norway recognized Latvia de jure (2021).
- 3) Iceland celebrates 100 years as a free and sovereign state (2018);
- 4) Presidency of Latvia in CBSS (July 1, 2018-June 30, 2019);
- 5) Presidency of Latvia in the Baltic Council of Ministers (2019);
- 6) Norway's candidacy to the membership in the UN Security Council.

# **1.4.** How can the funds best be used to promote and facilitate partnership projects under the programmes? The optimal use of bilateral funds in Latvia will vary between programmes based on the specificities of each programme. It is up to CC of each programme to decide how to best use the BF allocated in the MoU to promote and facilitate partnership projects under the programmes. Matchmaking, networking events, exchange of experience, success stories and other partnership events organised by PO could be used for facilitation of partnership projects.

#### 2. Main objective

Enhanced cooperation and improved mutual knowledge and understanding between Donor and Beneficiary States.

# 2.1. Please outline the main aims and ambitions for the Fund for bilateral relations with reference to priority sectors, programmes and measures. Please include reference to any areas of common bilateral interest highlighted in the MoU that should be prioritised, as well as the areas identified by the Joint Committee for Bilateral Funds?

Bilateral relations between DS and Latvia shall be strengthened with the aim of stimulating and developing long-term cooperation within all areas listed in the Annex to Protocol 38c to the EEA Agreement and the Agreement between the Kingdom of Norway and the European Union. It is also an ambition to strengthen bilateral cooperation at political level and European level in areas of common interest. Bilateral priority programmes set in MoU are listed in section 4 "Bilateral Priority Programmes". Main strategic areas for initiatives beyond the scope of the bilateral priority programmes identified by the JCBF are as follows:

- 1) education and research (cooperation between universities, institutes and libraries; people-to-people contacts, cooperation within think-thanks, youth development; media development of the independent media and media literacy, research in the field of security policy);
- 2) art and culture (exchange of cultural experiences, exhibitions, concerts, cultural days, conservation of the cultural heritage; translation and popularization of Latvian literature; celebrations of centenary of Latvia);
- 3) cooperation projects between local governments (twin towns) (conferences and other type of networking and exchange of ideas between Latvian and DS local governments);
- 4) promotional activities for business development and bilateral cooperation (conferences and other type of networking and exchange of ideas between Latvian and DS organisations);
- 5) promotional events for bilateral cooperation (EEA and Norway Grants events and other events at conversation festival LAMPA in Cesis, Norwegian days in Latvia, etc.);
- 6) promoting transparency and democratic participation.

Flexible implementation of the BF is foreseen, therefore above mentioned strategic areas could be altered or supplemented during the implementation period and amendments in this work plan can be initiated by JCBF members.

### 2.2. The modalities for allocating funds should be outlined, e.g. calls, pre-defined activities, activities carried out by the NFP, allocations to Programme Operators. Key issues and upcoming larger events should be included.

Allocation of the BF to strategic initiatives is foreseen through pre-defined initiatives. Such pre-defined initiatives will cover strategic areas of support, possibly including upcoming, larger events. According to the MoU one pre-defined initiative is foreseen to be implemented by BCME (presented in section 5 "Major Activities").

As well in the MoU allocation is made to 6 programme operators for implementation of programme initiatives (presented in section 4 "Bilateral Priority Programmes"). Decision on the management and use of all bilateral funds at programme level will be made by the respective PO (in cooperation with the DPP in the CC, where relevant).

#### 2.3. Please also shortly describe the management of Bilateral Funds, including the selection process.

The BF will be managed:

- 1) at strategic level by the JCBF. JCBF operates according to "Composition, Role and Functioning of JCBF 2014-2021" annexed to the Agreement on the BF signed between the Donors and NFP.
- 2) at operational level by the NFP;
- 3) national review of initiatives will be ensured by an Advisory Working Group. It is an advisory body established according to the horizontal Regulations on the management of FM 2014-2021 approved by the Latvian Government and chaired by NFP to nationally discuss and to provide opinion about initiatives submitted to the secretariat of JCBF before the review of initiatives in JCBF as well as to provide national proposals for initiative.

Institutions involved in the management of the BF is presented in the Annex 1 and the selection process in Annex 2.

#### 3. Implementation system

Please include a brief description of the implementation system for the Fund for bilateral relations. The modalities for allocating funds should be outlined, e.g. calls, pre-defined activities, activities carried out by the NFP, allocations to Programme Operators. A more detailed description will be included in the detailed description of the management and control systems.

The implementation system for the BF is in line with the DS Regulation and Bilateral Guidelines, as well as with the national normative acts.

#### The BF has two parts:

- 1) **programme initiatives**. Bilateral funds are already allocated to the programmes through the MoU (700 000 EUR as outlined in the overview under section 4). POs can request additional funds from the JCBF through expression of interest form (annex 4 of DS "Bilateral guidelines"). Decision on the management and use of bilateral funds at programme level will be made by the PO (in cooperation with the DPPs, where applicable, in the CC). NFP as observer in CC has a possibility to monitor and facilitate the use of the funds for bilateral relations at programme level. Provisions concerning implementation of programme initiatives (inter alia eligible applicants, expenditures, applicable state aid rules (if any)) will be included in the Programme's Regulations to be approved by the Latvian Government.
- 2) **strategic initiatives**. Pre-defined initiatives are foreseen with the indicative threshold 10 000 EUR and above in order to avoid unnecessary administration and to ensure visible results. JCBF members can propose initiatives at any time through proposal on strategic initiative<sup>1</sup>. Promoters of the initiatives can be Latvian and DS institutions (state institutions, municipalities, NGOs etc.). Provisions concerning implementation of strategic initiatives (inter alia eligible applicants, expenditures and that only strategic initiatives without state aid can be supported under the BF) is included in the horizontal Regulations on the management of FM 2014-2021 approved by the Latvian Government.

#### Submission and approval of bilateral initiatives:

- 1) PO, JCBF members and representatives of the national Advisory Working Group may submit initiative's proposal to the NFP at any time when it is fully developed and partnership is established. Promoters of the initiatives can be any Latvian or Donor States entity. The NFP will provide assistance to the promoters of initiatives with practicalities regarding filling in the application form (proposal on strategic initiative and expression of interest form for programme initiatives). As well informative material on implementation of strategic initiatives prepared by NFP is available<sup>2</sup>.
- 2) NFP provides administrative check of initiative's proposal according to the checklist<sup>3</sup>. If necessary, the promoter of initiative improves initiative's proposal.
- 3) NFP submits initiative's proposal to the Advisory Working Group for review and opinion. In case of the donors initiative, initiative's proposal will be sent to JCBF for consideration as well.
- 4) After the Advisory Working Group, NFP ensures submission of initiatives for decision in the Latvian Government for approval of national initiatives or provision of opinion on donor states infinitives. NFP can report about initiatives to the Latvian Government often like twice a year, it will be ensured case-by-case corresponding to planned start of initiative.
- 5) NFP ensures submission of initiative for decision in JCBF depending on planned start of initiative. In parallel to the process of submission of initiatives for decision in the Latvian Government or after decision is taken by the Latvian Government.
- 6) JCBF takes decision about initiative. If it is prior decision of the Latvian Government, then JCBF takes decision will be with conditionality of approval by the Latvian Government.
- 7) NFP informs promoter of the initiative about decision of JCBF.

8) FMD prepares the draft agreement<sup>4</sup> to be coordinated with the promoter of initiative (provisions for POs are set in the horizontal Regulations on the management of FM 2014-2021 approved by the Latvian Government). Implementation of the initiative starts after the conclusion of the agreement. Process of submission and approval process is presented in Annex 2.

#### Reporting on bilateral initiatives:

- 1) Submission of reports to NFP on expenditures incurred under the BF is foreseen at least once per year:
  - 1.1. programme initiatives. PO reports to NFP on expenditures incurred by PO and promoters of programme initiatives. PO will ensure verification of expenditures incurred by promoters of programme initiatives. If PO is promoter of programme initiative, then a competent and independent public officer or an independent auditor contracted by PO will ensure verification of POs' expenditures. If in the report PO's expenditures will be included, POs shall submit the report together with a report by a competent and independent public officer or an independent auditor. Provisions regarding reporting by PO to NFP is included in the horizontal Regulations on the management of FM 2014-2021 approved by the Latvian Government.
  - 1.2. strategic initiatives. Promoter of strategic initiative report to NFP on expenditures incurred by promoter of strategic initiative. A competent and independent public officer or an independent auditor contracted by promoters of strategic initiatives will ensure verification of expenditures incurred by promoter of strategic initiative. Promoter of strategic initiative shall submit the report together with a report by a competent and independent public officer or an independent auditor. In case if NFP is promoter of strategic level initiative, then the CA will ensure verification of expenditures incurred by NFP.
- 2) Verification of reports:
  - 2.1. FMD verifies: financial part of reports submitted by POs and promoters of strategic initiatives; whether the auditor is qualified to carry out such audit; and whether audit report certifies that claimed costs are made in compliance with Regulation, national laws and relevant national accounting practices.
  - 2.2. NFP verifies: content of reports submitted by the PO and promoters of strategic initiatives will be verified on base of initiative approved in the JCBF.
- 3) FMD compiles Interim Financial Reports and submits its to the CA.
- 4) CA certifies Interim Financial Reports and submits them to the FMO bi-annually.
- 5) NFP ensure strategic reporting on the overall progress towards achieving the bilateral objectives in the Strategic Report annually. The bilateral section of the draft Strategic Report will be consulted with the JCBF prior submission of the Strategic Report to the FMO.

Short description:	The main aim of this initiative is to make verified knowledge and understandable common-interest information more easily available to the general public of Latvia and Norway, in the context of misinformation, fake news and propaganda. This will be done through strengthening the competence of the editorial teams of the National Encyclopaedia (NE) and Store norske leksikon (SNL) of Norway. This includes the exchange of editorial policies, workflow methods, best practices and technical solutions, but also an increased understanding of the historic, societal, political and educational context of each country, in addition to their media, communications and misinformation landscapes. This will be done through three workshops that will be organized by and for the editorial teams of the two encyclopaedias, where both in-house and external expertise will be engaged to enhance the encyclopaedias' outreach to the public in the respective countries and strengthen and improve both content and technical solutions. Initiative is based on the idea of making available dissemination of the information for the wide public audience through modern and forward-looking media — expert-written encyclopaedia. Renaissance of the encyclopaedic approach is gaining strength currently in Europe which is evidenced by the recent activities in various countries finding solutions to the fight against disinformation and fake news. Even more — encyclopedias, as is shown in both Latvian and Norwegian case, could be essential in producing valuable extra-curricular content for the general educational institutions and the institutions of higher education. National encyclopedias also provide additional impetus for the securing place to the smaller languages, non-English native speaking population in the knowledge-based environment, using academic resources in providing reliable information to the general audience via their native tongue.
